SUPERVISOR COMMENTS

Sunday night turned into a very busy night for the graveyard crew. Officers assisted swingshift in locating and arresting a suspect wanted for vandalizing several cars at a local establishment. The vehicle was located, with the help of an air unit. The driver was found to be under the influence. Officers then started to investigate a domestic violence incident. The suspect was no longer home (the victim came to the police department to make the report). A little while later the suspect was seen driving near the home. Officers tried to stop the vehicle but he refused and he attempted to evade and flee from officers. A pursuit ensued, which led officers through most of the north end of town. The vehicle eventually made it to northbound Highway 99, and the pursuit was taken over by the Sheriffs Dept. the suspect eventually yielded near the city of Manteca after his vehicle was disabled by spike strips. He refused to exit the vehicle and a Sheriff K9 was utilized to make the apprehension. The suspect was taken to San Joaquin General Hospital for treatment and will be booked into jail for several felony violations.
