#### SUPERVISOR COMMENTS

Today was another repeat of the prior day, in regards to call volume and officers being busy. Officers responded to several domestic violence type of calls, as well as several calls involving juveniles. Towards the beginning of the shift officers responded to a disturbance at a residential neighborhood. After de-escalating the situation, and discovering that there was no actionable crime that took place, they discovered that the initial caller had an outstanding warrant. Shortly after that person was arrested, and was being transferred to the jail, officers responded to the residence a second time. This time the arrested party's relatives were upset with the other involved party for the arrest, believing they were the reason their family member was arrested. By the time officers arrived, the instigating party had left the area. Later in the day, officers responded to an argument and placed a female on a mental health hold. She had cut herself while arguing with her husband, after realizing their relationship was possibly ending.

#### **SUPERVISOR COMMENTS**

The shift was busy. Officers were notified of a male with a felony warrant out of Placer County for sex offenses. They located him and he was arrested and booked. Officers investigated an aggravated assault with a bat and another assault/battery case involving domestic violence. An officer observed two cars racing on Lander Ave. One was stopped and the driver was arrested and his vehicle was towed. This was his second ticket recently for reckless driving. Another officer attempted a traffic stop on a vehicle and the driver fled. A short pursuit ensued and the driver then pulled over. He was arrested for evading and the vehicle was towed. Officers responded to a call of a suicidal female who jumped out of a two-story window. Luckily, she sustained only minor injuries and was transported to the hospital by ambulance with a mental health evaluation hold placed.

#### SUPERVISOR COMMENTS

Officers responded to several assault & battery calls last night. One investigation involved a male who was waiting outside of his girlfriend's residence for her to get home after going out. The male fled before officers arrived and he was not located. Due to the fact that the male lives outside the county, a Ramey Warrant was obtained for his arrest.
