SUPERVISOR COMMENTS

Officers were steady throughout the day, although not a busy as it was yesterday. While not responding to calls for service, officers made several contacts with suspicious people and made traffic enforcement stops. Calls of note today include a larceny from a fenced in yard. The yard contained several work trucks and the company is currently compiling a list of what items and told were stolen, and gave a rough estimate of \$4000 in value. The yard does not have an alarm system, but is guarded by a watch dog. Officers also responded to a disturbance between a mother and son. The son had left prior to the officers' arrival. The mothers age elevated the incident to elder abuse. The mother did not want to have her son arrested, however the report was sent to the District Attorney's Office for review of criminal charges. While she did not want an emergency protective order due to the son not living with her, the officer took the initiative to get one granted anyway.

SUPERVISOR COMMENTS
