This afternoon, officers investigated a call at a store where one patron assaulted another patron for no apparent reason. Store employees stepped in to stop the assault. The adult female suspect was arrested and booked.

SUPERVISOR COMMENTS

Officers investigated a missing person report involving a 62-year-old female who suffers from schizophrenia, diabetes, and high blood pressure. She was last seen three days ago, and left her cell phone and medications at her home. Officers had to force entry into the home to security check her, but she was not in her home. She was entered as missing at-risk. Officers also investigated a domestic disturbance. The male half was intoxicated and started an altercation with his girlfriend. No crime was determined at the time, but hours later officers responded to another call involving the same couple. The second incident occurred in the County jurisdiction, so they responded to take the report. At that time the female disclosed information from the prior incident that caused her to be in fear of the male. We obtained an emergency protective order and served the male after he was arrested and booked for public intoxication.

SUPERVISOR COMMENTS

Officers responded to the Safeway parking lot after Turlock Fire called to report a male who was driving erratically and becoming confrontational with Fire personnel when confronted. When officers arrived, the male was quickly detained due to his belligerent demeanor. He was displaying obvious signs of intoxication and ultimately arrested for drunk driving. After a search incident to arrest he was found in possession of methamphetamine. He was booked into jail. Officers also responded to a call of a male who was trying to break down the front door of a residence. He was gone when officers arrived and it was determined he had been contacted earlier in the night for a domestic disturbance. While on-scene officers obtained information that the male was now at a county address banging on the front door. It was determined he was drunk and looking for his girlfriend who he thought was cheating on him. The Sheriff's Officer was notified and officers responded to assist. When officers arrived, they located the male and detained him. He was arrested for public intoxication and taken to jail, due to deputies having an extended ETA. Deputies responded later for the report.
