#### **SUPERVISOR COMMENTS**

Swing shift was extremely busy throughout the entire shift. With all the calls for service, plus the National Night Out event, Officers did not have much free time. The shift started off with

a shoplifting call in which the suspect was arrested. It was found that he also had a warrant from another jurisdiction. He was arrested for the theft and the warrant. Officers then responded to a domestic violence situation in which the male half was arrested for felony domestic violence. He was taken to jail and a n emergency protective order was issued by a judge. As that was being wrapped up, officers responded to an aggravated assault in which a female was stabbed by another female. The assailant was located and arrested. The victim did not have life threatening injuries, but she was taken to the hospital for treatment. Finally, officers responded to a deceased person being found in the back yard of a vacant home. It turned out to be a missing person that was reported a day prior. Detectives were called out and they took over the investigation. As of now, it appears that she committed suicide. The county coroner came to the scene and took custody of the body.

**SUPERVISOR COMMENTS**

Officers responded to a trespassing call that was in-progress. A male, who was determined to be the ex-boyfriend of the victim, had forced his way into the victim's apartment, causing her to lock herself in the bathroom and call police. The male entered the residence and began to smoke the victim's marijuana. When officers arrived, they located the male in the apartment and immediately detained him. It was found that the male and female were in a dating relationship, but the relationship ended eight months ago. The victim had not been in contact with him since, until today when this incident occurred. He was placed under arrest and booked for burglary. Officers also contacted an occupied suspicious vehicle in the Motel 6 parking lot. The male in the car was determined to have an I&B out Stan Co Sheriff's Department for theft with priors. He was placed under arrest and during a search of the vehicle officers located numerous designer clothing items and accessories that still had the store tags on them. Officers also discovered a license plate cover used to be undetected for license plate readers, and a store clothing sensor remover. Additionally, a loaded firearm was found. the male was arrested for the I&B and additional new charges. He was booked into jail.
